

# RELEASE TO PRINT ARTWORK (& RELATED TEXT)

19 November 2012

Dear Artist:

Jeff Hamada is preparing a book which shall be a collection of artworks by contemporary artists, tentatively entitled REMAKE (the "Work"). We would like to include your REMAKE submission (the "Artwork") in the Work.

In order to include the Artwork in the Work, we need to have this form completed by you and returned to us along with the delivery of high-resolution digital files of the image(s) described above. All materials, including this release, may be sent as digital files to projects@booooooom.com. For larger files, please use a transfer service, such as YouSendIt, DropBox, or similar and include a low-resolution thumbnail of the image in the email.

This letter confirms the agreement between Jeff Hamada and yourself regarding the right to print, publish, license, transmit, distribute and sell the Artwork (including the related text), in whole or in part, in and in connection with Chronicle Books's publication of the Work.

With respect to the Artwork (including any related text), you grant Chronicle Books and its licensees and assignees the following nonexclusive rights to use the Artwork throughout the world: (i) the right to publish and license the use of the Artwork in all editions of the Work, including book club and digital editions; (ii) the right to license use of the Artwork as part of excerpts from the Work to magazines, newspapers, and other periodicals; (iii) the right to use the Artwork and the artist's name on the cover of the Work; and (iv) the right to use the Artwork in promotional material for the Work, including but not limited to advertising, articles, and reviews.

The Work shall include an acknowledgment for the use of the Artwork, either directly in conjunction with the Artwork itself, or on the acknowledgments page of the Work, which acknowledgment shall read substantially as follows:

Chronicle Books may vary the format of the acknowledgment as needed to conform to their current standard form. Further, it is agreed that Chronicle Books may edit the text submitted to adhere to its style guidelines and may make reasonable other edits with respect to form and style to fit the needs of the Work.

You warrant, and indemnify Chronicle Books of such warranty, that you are the sole owner of the rights to the Artwork (and related text) hereby conveyed, that you have the authority to enter into this agreement, and that the Artwork (and related text) and Chronicle Books's use of the Artwork (and related text) do not infringe on the rights of any other person.

You shall receive two complimentary copies of the Work. Please include your address under your name below, so that we know where to mail the complimentary copies.

This letter of agreement and release will remain in effect for as long as the Work is in print from Chronicle Books or for as long as any rights are being exercised by its licensees or assignees.
